(the Company) (NYSE: SB), an international provider of marine drybulk transportation services, announced today that it will release its results for the quarter ended December 31, 2012 after the market closes in New York on Wednesday, February 20, 2013. The Company also expects to announce the declaration of a dividend for the fourth quarter 2012 at that time.

The Company's current fleet consists of 24 drybulk vessels, all built post-2003, and the Company has contracted to acquire 7 additional drybulk newbuild vessels to be delivered at various times through the 2015.
