The Company is an international provider of marine drybulk transportation services, transporting bulk cargoes, particularly coal, grain and iron ore, along worldwide shipping routes for some of the world's largest users of marine drybulk transportation services. The Company's common stock is listed on the NYSE, where it trades under the symbol "SB". The Company's current fleet consists of 26 drybulk vessels, all built post-2003, and the Company has contracted to acquire 6 additional drybulk newbuild vessels to be delivered at various times through the 2015.
